This privacy policy explains how we collect, protect, use and share information about you online and offline. Please note that this privacy policy (Privacy Policy) applies only to information collected by Sacoor. It does not apply to information that you may submit to other websites or through social network services maintained by other companies or organizations to which we may link.

1. Your data

This site shall not collect your personal data, unless you provide it voluntarily. We may also use and provide clustered and statistical information to third parties to monitor the use of our website, to help us develop and improve the website and our services. This data does not include information that could be used to identify a specific individual.

Also, we may retweet, repost, repin your publications in social media platforms where you have tagged us, our brands, products and services.

We may use your contact details to send you information and updates regarding your orders, transactions and the Sacoor Club membership. We may also contact you for occasional Sacoor updates about products or services.
